FROM SPRINGFIELD: Merge onto I-91 North, take the Route 2A exit/Exit 26 toward Route 2/Greenfield/North Adams. Enter next roundabout and take first exit onto MA-2 West. Turn right onto MA-8/Holden Street, left onto MA-8/Saint Anthony Drive, right onto Marshall Street, left onto River Street, then left onto Brown Street.

TURNPIKE FROM WORCESTER: Merge onto I-290 West toward Auburn and take the I-90 exit/Exit 7 toward Massachusetts Turnpike/Route 12 North Auburn. Take the I-90 ramp toward Massachusetts Turnpike, keep left at the fork in the ramp. Merge onto I-90 West/Massachusetts Turnpike/Massachusetts Turnpike (Portions toll). Merge onto I-91 North via Exit 4 toward Holyoke. Take the Route 2A exit/Exit 26 toward Route 2/Greenfield/North Adams. Enter the next roundabout and take first exit onto MA-2 West. Turn right onto MA-8/Holden Street, left onto MA-8/Saint Anthony Drive, right onto Marshall Street, left onto River Street, then left onto Brown Street.
