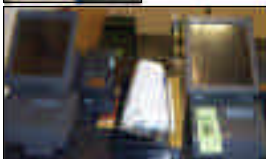
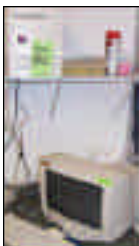

DIRECTIONS: Here's how to get to Nathan's for INSPECTION PURPOSES ONLY:

1. From Hartford and points East: Follow I-84 West to exit 40. Turn right on New Britain Avenue (Rte. 71).
2. From Farmington and points West: Follow I-84 East to exit 40. Turn right on New Britain Avenue (Rte. 71).
3. From New Britain and points South: Follow Route 71 to Westfarms, or take Route 9 North to exit 30. At the end of the exit ramp, turn right at the light onto New Britain Avenue (Rte. 71).
4. From Western Massachusetts and points North: Follow I-91 South to I-84 West. Take exit 40 off I-84 and turn right onto New Britain Avenue (Rte. 71).
5. From the Connecticut shoreline and points South: Follow I-91 North to Route 9 North. From Route 9, take exit 30. Make a right at the light at the end of the exit ramp onto New Britain Avenue (Rte. 71).

3. Take Exit 45 – Warehouse Point/Ellington (CT-140)
4. Turn RIGHT onto CT-140
5. Turn LEFT at top of hill onto US-5
6. Drive approx. 2 miles. 1654 King Street (US-5) is on your left on the corner.
7. Park around back of building and enter thru side door, look for auction signs!
